PRECAUTIONS: PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Severe eye, skin and respiratory tract irritant. Use full face shield with goggles. Wear cuffed butyl rubber gloves, slicker suit and rubber boots when handling. Use a NIOSH approved vapor respirator under emergency conditions.

FIRST AID: In case of eye contact hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.
