## INSECT STOP CRAWLING INSECT DESTROYER POWDER

### DIRECTIONS FOR USE:

Apply powder by using handy squeeze bottle with the extension tube inserted into the top opening. This allows the placement of INSECT STOP Crawling Insect Destroyer Powder into cracks and crevices where insects hide. Apply small quantities of powder directly into cracks and crevices behind stoves, cabinets, sinks, refrigerators, etc. Remove lower drawers from cabinets and treat drawer wells, treat cracks along baseboards and in corners. Any powder visible after application should be brushed into cracks or removed. Re-apply if reinfestation occurs.

### PRECAUTIONS:

**KEEP OUT OF REACH OF CHILDREN.** Harmful if swallowed, inhaled or absorbed through the skin. Avoid contact with eyes, skin, clothing and avoid inhalation. Wash thoroughly after handling and before eating, drinking etc. Do not apply to plants, animals or humans. Remove pets and fishbowls from area before treatment and do not return them for at least 4 hours after treatment. Do not apply to surfaces that children or pets might contact. **DO NOT CONTAMINATE FOODSTUFFS.** Do not use in any area where food may be exposed. Do not use in cupboards where food or cooking utensils are stored. In homes or dwellings remove or cover all exposed food and cooking utensils before using. Thoroughly wash all surfaces that might contact food before reuse.

**FIRST AID:** If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

### TOXICOLOGICAL INFORMATIONS:

Treat symptomatically.

**DISPOSAL:** Do not reuse empty container. Wrap empty container and discard with garbage.
