DIRECTIONS FOR USE

For use in the manufacture of roofing shingles. Mix AR Granules (Algae-Resistant Roofing Granules) with standard roofing granules at a rate of 5-10% by weight and process normally during manufacture of the shingles.

If granules are to be stored prior to (and during) use, a copy of this label must be made readily accessible to employees when they are in their work area(s).

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

DO NOT apply this product in a way that will contact workers or bystanders, either directly or through drift. Only protected handlers may be in the area during application.

DO NOT apply this product directly to freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs and wetlands), or estuarine/marine habitats.

PRECAUTIONS
