DIRECTIONS: BUGFIX is ready to use. Its special formula is nonstaining, and has no conspicuous odour. Water, not petroleum distillate is used as the diluent. **SHAKE WELL BEFORE USING.**

INDOOR PESTS: Spot treat for the control of ants, cockroaches, spiders, silverfish and sowbugs. Apply to areas where these crawling pests may enter or hide such as along door sills and base boards, in cracks and crevices in walls and floors, behind and beneath sinks, and refrigerators, etc. Spot treatment for house flies. Spray around windows and doors where houseflies alight. Do not use in food storage areas or on surfaces that may contact foods. Spray until surface is damp but not to the point of run-off. Repeat as necessary.

INDOOR PLANT PESTS: Controls aphids and whitefly. Safe to use on most plants. Before treating delicate plants such as Coleus and African Violet spray 1 or 2 leaves. If no effect is noticed after 2 days it is safe to treat whole plant. Do not spray to run-off. Repeat treatment as necessary.

OUTDOOR PLANT PESTS: Controls aphids, leaf eating caterpillars, thrips, and leafhopper on ornamental plants. Do not use on fruits and vegetables. Wet upper and lower leaf surfaces thoroughly. Do not spray to run-off. Spray when insects first noticed and then as required.

PRECAUTIONS: **KEEP OUT OF THE REACH OF CHILDREN.** Keep children and pets away from treated areas, at least until spray has dried. Do not use as a space spray. Avoid contamination of food, feed, cooking utensils or drinking water. Wash thoroughly before eating, drinking and smoking. This product is very toxic to fish. Remove fish bowls and aquariums from the treated area.

FIRST AID:

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you, when seeking medical attention.

DISPOSAL:
