DIRECTIONS FOR USE:

Using conventional methods of application, deposit 0.25% - 0.5% (as received) on the dry weight of material being treated. Products containing this chemical are not to be used in food packaging materials or in areas where food is stored, handled or processed.

PRECAUTION:

Keep Out of Reach of Children. Corrosive. Harmful if swallowed. Causes severe eye and skin damage. Do not get on skin, in eyes, or on clothing. Wear protective clothing and goggles to prevent contact with skin and eyes. Avoid breathing spray mist. Wash thoroughly after handling. Keep out of lakes,

ponds and streams. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not re-use container. Destroy when empty.

FIRST AID:

Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
