#### **DIRECTIONS FOR USE**

Metasol TK-100 Powder can be added at any stage in the formulation, providing there is sufficient agitation to properly disperse it throughout the finished product. Levels will range from 0.02 to 0.3% depending on the application. This can only be determined by laboratory evaluation.

#### **PRECAUTIONS**

**KEEP OUT OF REACH OF CHILDREN. HAZARDS TO HUMANS AND DOMESTIC ANIMALS. CAUTION.** Wear chemical resistant gloves when handling this product. Do not contaminate water by cleaning of equipment or disposal of wastes. Wash hands with soap and water after handling.

#### **FIRST AID**
