**FIRST AID:**

**For eye contact:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **For skin or clothing contact:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. **DIRECTIONS FOR USE:**

**INITIAL TREATMENT:** SANI – MARC PERMANENT ALGAECIDE must be used to prevent algae growth. Superchlorinate pool for several hours prior to adding algaecide. Allow chlorine residual to return to normal before using pool (1-2 ppm). Under normal use conditions, one application of this product should be used during the season. Add at the rate of 1 L for every 10,000 L of pool water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

**PRECAUTIONS:**

**CAUTION:** Harmful if swallowed. **KEEP OUT OF REACH OF CHILDREN.** Avoid contamination of food. Rinse empty container thoroughly with water and discard it. Do not reuse. Avoid contact with skin or eyes. This product is toxic to fish. Treated pool water should not be discharged where it will drain into lakes, streams, ponds or public water.

**IMPORTANT:** Do not mix with any other chemical. Always add directly to pool. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.
