DIRECTIONS: SPOT OR CRACK AND CREVICE – For outdoor use only. Do not use indoors. Apply as a coarse spray to infested areas until wet. Direct spray away from people, plants and pets. Outdoor application is limited to crack, crevice, and structural treatments and must not be applied to vegetation, plants, grass, and/or area accessible to children.
