DIRECTIONS FOR USE:

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL HARMFUL IF SWALLOWED AVOID INHALING OR CONTACT WITH SKIN AND EYES When handling this product, wear coveralls over a long-sleeved shirt, long pants and chemicalresistant gloves.

FIRST AID:
