DIRECTIONS:

As a space spray, application should be carried out at weekly intervals depending upon the rate of infestation. Apply PRO PYRONIDE 5 Insecticide at a rate of 100-200 mL per 100 m³ using a machine that produces an aerosol mist. When using a thermal fog generator, apply no more than 320 mL/m³. Close all doors and windows and shut off all ventilating systems. Direct spray upwards to all parts of room, especially windows, light sources and other areas where insects are present. Spray only when temperature is less than 32° C. Keep area sealed for at least 30 minutes. DO NOT remain in treated area. Ventilate building for at least 30 minutes before re-entering. Following ventilation, clean up dead insects.

As a surface spray, apply at an even rate of 5 L/100 m². Apply spray into all cracks, crevices, and hiding places such as baseboards, moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas. Spray must contact insects for control.

In food processing plants and food service establishments, apply only when plant is NOT in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operation.

For meat packing plants, treat only when plant is NOT in operation. No exposed meat products, ingredients or packaging materials should be kept in the room. Cover food handling equipment. All treated surfaces that may contact meat or other food products should be washed and rinsed thoroughly with potable water after treatment and before reuse for food processing.
