FIRST AID INSTRUCTIONS

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

PRECAUTIONS

KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Do not contact skin. Avoid contamination of feed and foodstuffs. Cover or remove all foods before spraying. Cover or remove fish bowls and remove all pets. Contents under pressure. Do not puncture or expose container to temperatures above 49°C. Never throw container into fire or incinerator. Keep from freezing.

DIRECTIONS FOR USE

Shake well before each use. Remove protective cap. Aim spray opening away from person. Push button to spray.

FOR HOUSEFLIES, MOSQUITOES, AND GNATS: Close all doors and windows. Point nozzle upward, direct spray mist to all parts of the room, especially windows and other light sources which attract these insects. Fill the room with mist, then leave the treated area. Spray 5 to 10 seconds for every 28.3 cu meters of space. Keep the room closed for at least 15 minutes. Ventilate room when treatment is completed.

WASPS: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places contacting as many insects as possible. Repeat as necessary.

FOR CRAWLING INSECTS: **Cockroaches, Earwigs, Grain Mites, Sowbugs, Spiders** and **Centipedes**: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards, and storage areas. Spray directly on insects where possible.

ANTS: Spray trails, nests and points of entry. Spray on ants where possible. Repeat as necessary.

STORAGE AND DISPOSAL

Do not use or store near heat or open flame. When container is empty, press valve to release remaining pressure. Wrap and dispose of used container with household garbage.
