GENERAL INFORMATION:

TERRANEB SP turf fungicide wettable powder is recommended for the treatment of turfgrasses for the control of snow mold (Typhula) and Pythium blight.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN

Harmful if swallowed. May irritate eyes, nose, throat and skin. Avoid breathing dust or spray mist. Avoid contact with skin, eyes and clothing. Wash hands before eating or drinking. Wear waterproof gloves when mixing and handling. Do not graze or feed clippings from treated areas to livestock. Toxic to fish. Do not apply to water or contaminate water ways when cleaning equipment.

FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If inhaled :** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL:

1. Make the empty container unsuitable for further use.
2. Dispose of the container in accordance with provincial requirements.

DIRECTIONS FOR USE:

TURF DISEASES

GRAY SNOW MOLD(Typhula sp.) - For the control of Gray Snow Mold, apply 175-275 g of TERRANE B SP turf fungicide wettable powder per 100 m² in sufficient water to give complete coverage, usually 15-20 L. Apply as a spray as late in the fall as possible prior to snowfall.

PYTHIUM Blight - For control of Pythium blight on established turf, apply TERRANE B SP turf fungicide wettable powder as a preventive at a rate of 125 g per 100 m² in 15-20 L of water. Apply during periods of high temperature and humidity favourable to the development of disease. Repeat in 5 to 7 days if conditions persist.

For the control of Pythium blight on new seedlings, apply TERRANE B SP turf fungicide wettable powder at the rate of 125 g per 100 m² immediately after seeding. Repeat in 7 to 10 days if conditions remain favourable to the development of disease.
