DIRECTIONS FOR USE: For use as a crack and crevice or spot treatment only. Spray surfaces until wet. Do not spray people, plants or pets. Do not allow children or pets to contact treated surfaces until surfaces are completely dry.

INDOOR USE: Bugcon Roach and Ant Killer

Kills cockroaches, ants, crickets, silverfish, spiders, saw-toothed grain beetles (exposed stage). Spray into cracks and crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves and in and around waste containers. Repeat as needed. Do not spray foodstuff or house plants. Avoid contamination of food, utensils and food preparation areas. Do not use where food is prepared, handled or stored.

OUTDOOR USE: Bugcon Roach and Ant Killer

Kills ants, clovermites, crickets, earwigs, fleas, millipedes, sow bugs, brown dog ticks. Spray infested areas including outside surfaces of screens, doors, window frames, foundations, patios or other places where insects may enter. For ants, spray hills and runways, trails and places where ants enter premises. Repeat as necessary. Do not spray vegetation. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. FLAMMABLE. Contents under pressure. Do not puncture or incinerate. Do not expose to temperatures over 50°C. Do not place container in hot water or near stoves or other sources of heat. Do not use near open flame or spark. Do not smoke while using. Do not spray towards eyes. Harmful

if swallowed, inhaled or absorbed through the skin. Avoid contact with skin, eyes or clothing. Avoid breathing of spray mist and use with adequate ventilation. Do not use as a space spray. Remove pets and cover fish bowls before spraying.

FIRST AID: If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Atropine sulfate is antidotal. Use oxygen therapy and treat symptomatically for poisoning. Contains petroleum distillates.

DISPOSAL: When empty, press valve to release all remaining pressure. Wrap and discard in household garbage.
