#### **FIRST AID**

Liquid MAGNACIDE™ B Microbiocide Technical is absorbed by the skin and is particularly irritating to any lesion and to the eyes. The vapors act principally on the mucous membrane of the eyes and respiratory tract. Because of the extreme lachrymatory warning effect, the concentration tolerable by man is far below the minimum lethal concentration. Persons exposed to MAGNACIDE™ B Microbiocide Technical vapours have a delayed reaction and experience irritation of the respiratory tract. In severe cases, this may progress to pulmonary edema. If ingested, probable mucosal damage may contraindicate the use of gastric lavage.

Treat exposed area as a chemical burn. Thoroughly flush the eyes with water and treat symptomatically. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON.

Do not apply with equipment used for acids and alkalies. Contamination of **MAGNACIDE™ B Microbiocide Technical** with any foreign matter must be avoided.

A supply of 10% soda ash solution should be readily available for neutralizing spilled **MAGNACIDE™ B Microbiocide Technical.** All spills should be confined and neutralized before disposal. Running water should be readily available to wash down the area after neutralization.

#### **ENVIRONMENTAL PRECAUTIONS**

This pesticide is toxic to fish and wildlife. Keep out of lakes, streams, or ponds. Fish, shrimp, and crabs will be killed at application rates recommended. Do not apply where they are important resources. Do not apply to natural bodies of water or to water drainage areas where runoff or flooding will contaminate ponds, lakes, streams, tidal marshes, and estuaries.
