DIRECTIONS FOR USE:

To be used only in the manufacturing, formulation or repackaging of a pest control product registered under the Pest Control Products Act.

PRECAUTIONS:

BY **UNAUTHORIZED PREVENT ACCESS PERSONNEL**: Avoid contact with skin, eyes or clothing. Wash thoroughly after using or before eating, drinking or Wear clean protective clothing, including chemical resistant gloves, goggles and respirator when handling manufacturing product.

ENVIRONMENTAL HAZARDS: Toxic to aquatic organisms. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.

FIRST AID:

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

STORAGE:
