**DIRECTIONS FOR USE:** For exterior use only. Not for use in dwellings. For above ground use only. Apply by brush only. Do not spray or dip. Do not use the preservative on treated wood where copper naphthenate may contaminate food, feed or drinking water. Wood surface to be treated should be dry and clean. Remove all paint, varnish, wax, or any other coating that may prevent penetration. Allow to dry thoroughly before painting or re-coating. Use caution with some paint finishes as they may cause bleeding. Use as supplied - do not dilute. Do not apply to wood or any surface where prolonged skin contact may occur. May be used on greenhouse and garden timbers in close contact with nonfood producing plants only. Carrier solvent must be allowed to dry before introducing plants to prevent phytotoxicity. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN. Do not use or store near open flame or spark. Harmful if swallowed or inhaled. Causes skin and eye irritation. Potential skin sensitizer. Avoid, breathing vapours, contact with skin, eyes and clothing. Wear a long-sleeved shirt, long pants, socks, shoes and rubber gloves when applying this product. Wash thoroughly after use with soap and water and before eating or smoking. Keep container closed when not in use.

**FIRST AID:** If splashed in eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. In case of skin or clothing contact, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Contains petroleum distillates and copper naphthenate. Treat as for ingestion of kerosene.

**ENVIRONMENTAL HAZARDS:** toxic to aquatic organisms.

**DISPOSAL AND STORAGE:** Do not reuse empty container. Dispose of empty container in household trash. Store unused product out of reach of children. Do not store in areas subject to excessive heat.
