Trounce Houseplant Insecticide is a fast-acting short-lived product. Hold container upright while spraying. Insects must be sprayed to be killed.

DIRECTIONS FOR USE:

FOR USE ON INDOOR ORNAMENTAL HOUSEPLANTS

To kill Aphids, Whitefly, Scale, Spider mites, Mealybugs: DO NOT apply to houseplants grown for food or feed (e.g., herbs). **DO NOT** use on greenhouse plants. When listed pests first appear, spray to thoroughly cover all foliage, including upper and lower leaf surfaces until damp. **DO NOT** wet plants to the point of runoff or drip. To enhance effectiveness of this product, apply directly to the listed pests where possible. **DO NOT** exceed 59.5 mL per m². Treatment must only be repeated after 10 days if pest problem persists or reoccurs. Use with caution on new growth and on tender young plants and foliage. Test on one or two leaves to determine safety.

PRECAUTIONS: KEEP OUT OF THE REACH OF CHILDREN. Product can cause skin and eye irritation. Avoid contact with skin and eyes. **DO NOT** apply to blossoms or when temperatures exceed 28°C. **DO NOT** apply using stationary or handheld fogging or misting equipment. **DO NOT** apply as a space spray. **DO NOT** use on sweetpeas, nasturtium, delicate ferns and certain varieties of impatiens. Schizanthus may be sensitive to topical foliar spraying. If in doubt, spray a small test patch prior to application.

FIRST AID:

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Skin exposure may cause transient sensations (tingling, burning, itching, numbness). Other symptoms of exposure could include respiratory effects (such as cough, respiratory irritation, or shortness of breath), nausea, headache or dizziness. Treat symptomatically.
