DIRECTIONS FOR USE

READ ALL DIRECTIONS CAREFULLY BEFORE APPLYING.

IMPORTANT: When using Companion, carefully follow all label directions for Roundup, Telar, Ally, Refine Extra, Muster, Amber 75WG, Avenge 640 and Rovral.

USE WITH ROUNDUP HERBICIDE

Companion increases the herbicidal effectiveness of Roundup when used in postemergence weed control for minimum or zero-tillage cropping systems in wheat, barley, and oats. To control the annual grasses and broadleaf weeds listed on the Roundup label (Minimum Tillage section), apply 450 mL of Companion plus 1.1 litres of Roundup in 50-100 litres of clean water per hectare.

USE WITH TELAR HERBICIDE

To control the broad leaf weeds listed on the Telar label, use 1 litre of Companion for each 1,000 litres of spray mixture.

USE WITH ALLY HERBICIDE

To control broad leaf weeds listed on the Ally label, use 2.0 litres of Companion for each 1,000 litres of spray mixture.

USE WITH REFINE EXTRA HERBICIDE

To control broad leaf weeds listed on the Refine Extra label, use 2 litres of Companion for each 1,000 litres of spray mixture.

USE WITH MUSTER HERBICIDE

To control wild mustard in canola, use 2 litres of Companion for each 1,000 litres of spray mixture.

USE WITH AMBER 75WG HERBICIDE

To control broad leaf weeds listed on the Amber 75WG label, use 2 litres of Companion for each 1,000 litres of spray mixture.

USE WITH AVENGE 640 HERBICIDE

To control wild oats in barley and the varieties of wheat listed on the Avenge 640 label, use 500 mL of Companion for each 100 litres of spray mixture.

USE WITH ROVRAL ON WHITE BEANS

To control white mold in white beans, use 250 mL of Companion for each 100 litres of spray mixture.

Mixing Instructions

Fill the spray tank at least half full with water and add the appropriate amount of Roundup, Telar, Ally, Refine Extra, Muster, Amber 75WG, Avenge 640, or Rovral while the agitation system is running. Complete filling spray tank with water and add the appropriate amount of Companion under constant agitation.
