DIRECTIONS FOR USE

To be used only in the manufacture of an acaricide which is registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS:

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. Avoid contact with skin, eyes, or clothing. Harmful if swallowed. May cause eye or skin irritation. Ensure good ventilation. Wear a respirator, goggles and chemical resistant gloves. Wash hands and exposed skin after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Thoroughly wash all contaminated clothing before reuse. Temperatures above 185°C causes clofentezine to emit toxic fumes which include hydrogen chloride and oxides of carbon and nitrogen. Do not contaminate irrigation water, lakes, streams or ponds by cleaning of equipment or disposal of wastes.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take the container label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Primary routes of entry are skin absorption and dust inhalation. Treatment should be supportive.

ENVIRONMENTAL HAZARDS:

TOXIC to birds. TOXIC to small animals. TOXIC to aquatic organisms.

STORAGE:

Keep in tightly sealed, original container during storage. Store in a cool, dry place away from water, feed, seeds, or foodstuffs. Do not store at temperatures below 0°C or above 50°C. Normal storage temperatures should be between 5-30°C.

DISPOSAL AND DECONTAMINATION:

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean-up of spills contact the manufacturer or the provincial regulatory agency.
