DIRECTIONS FOR USE

GENERAL INFORMATION:

Apply with equipment designed and adjusted to deliver a true aerosol mist. The use of this product in food processing establishments should be confined to time periods when the plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using.

DISPOSAL:

- 1. Triple or pressure rinse the empty container thoroughly and add the rinsings to the spray mixture in the tank.
- 2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
- 3. Make the empty container unsuitable for further use.
- 4. Dispose of the container in accordance with provincial requirements.
- 5. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

FOOD PROCESSING PLANTS, FOOD SERVICE ESTABLISHMENTS, FOOD STORAGE, FOOD TRANSPORTATION VEHICLES:

To control **Flies, Drosophilia, Gnats, Mosquitoes**: Close doors and windows and shut off ventilating systems. Use a fogger or sprayer adjusted to deliver a fine mist or fog. Spray upward to fill the room with a fine mist. Use 100 to 200 mL material per 100 cubic metres of space. Keep the area closed for 10 minutes. Vacate the treated area and ventilate before reoccupying. Repeat treatment as necessary.

Angoumois Grain Moths, Mediterranean Flour Moths, Indian meal Moths And Tobacco Moths: Close doors and windows, and shut off ventilating systems. Apply as a fine mist to insects hiding and breeding areas. If possible, hit insects directly. Expose one hour, then ventilate one hour before re-entry. Repeat treatment as necessary.

SURFACE SPRAY:

To Control Ants, Cockroaches, Crickets, Silverfish, Spiders:

Remove or destroy infested products to prevent reinfestation. Cover all food storage areas, then apply as a coarse droplet spray to surfaces where insects are found. For **Silverfish**, spray bookcases. For **Ants**, spray trails, nests and points of entry. Use 5 to 7 litres per 100 square metres. Repeat every 2 to 3 days until the infestations are eliminated. If possible, hit insects directly.

Cadelles, Cheese Mites, Cigarette Beetles, Confused Flour Beetles, Drugstore Beetles, Grain Mites, Granary Weevils, Mealworms, Red Flour Beetles, Rice Weevils, Sawtoothed Grain Beetles, Spider Beetles: Apply as above using a coarse wet spray to cracks and crevices where insects hide. Repeat as necessary.

To control **Carpet Beetles**: Spray edges of carpeting and under carpeting and rugs. Make a localized application to the floor and baseboards. Spray directly into cracks and crevices and infested areas of shelving. Repeat treatment as necessary.

To Control **Bedbugs**: Take the bed apart. Spray the frame and springs, especially cracks and crevices where the insects may hide. Spray the mattress with particular attention to the tufts and seams. Also spray cracks, crevices, baseboards and other possible hiding places about the room. Repeat treatment as necessary.

To Control **Fleas**: Spray sleeping quarters and other areas where infested animals stay. Fresh bedding should be placed in animal quarters following treatment. Product must contact the insects. Repeat as necessary. Concurrent treatment of animals with an insecticide registered for use on animals is recommended.

To Control (adult) **Clothes Moths**: Remove any infested articles from storage, brush thoroughly and air in sunlight for several hours. Spray suspected enclosure arranging clothes and other articles so that mist may circulate freely around them. Keep spray nozzle at least one metre from fabric to avoid staining. Close for 45 minutes after spraying. Store clothes in moth tight containers or repeat treatments monthly.

OUTDOOR AREAS (INCLUDING RESIDENTIAL AREAS, RECREATIONAL AREAS, WASTE AREAS, ROADSIDES, PASTURES):

To Control **Adult Mosquitoes**: Apply at a rate of 550 mL per hectare.

COLD AEROSOL GENERATOR: Apply as a fog in which the big majority of the particles are in the 5 to 50 micron range. Use equipment such as a truck-mounted LECO machine. Apply when there is a slight breeze, 10 kilometres per hour or less. Fog with the breeze. Apply with the discharge nozzle at 30 angle above the horizontal off the side of the truck.

BACK PACK APPLICATOR: Apply when there is a slight breeze, 10 kilometres per hour or less. Fog with the breeze.
