DIRECTIONS FOR USE:

Amerstat 272 may be used to control the growth of bacterial and fungal slime in pulp and paper mills.

In Paper Mill operation the dosage will normally vary from 0.1 to 1 kg of treatment per tonne of paper, depending upon the type on stock, complexity of the system, quality of the raw water and the type and degree of infection. this dosage is equivalent to 2.0 to 20.0 ppm of treatment for periods of 3 hours out of each 24 hours.
