K-G INDOOR AND OUTDOOR DOG AND CAT REPELLENT should be used in conjunction with training. For both indoor and outdoor situations, the most effective control for a pet is the sharply spoken word backed up with disciplinary action.

DIRECTIONS: Indoors, to break your pet of undesirable habits, such as sleeping on furniture, rugs and other forbidden areas in your home, spray the article of furniture, rug, etc. lightly with the repellent so that the area or object is slightly moistened. Before spraying extensive areas of rugs, fabrics or plastics, test the effect of the repellent by first treating a small inconspicuous area. The repellent may stain or soften some fabrics or plastics. An alternate method to avoid possible damage is to spray a piece of cloth lightly and place it on the object or area in your home to be protected. Repeat daily, until undesirable habit is broken.

Outdoors, to prevent your pet, or stray animals from soiling flowerbeds, areas of lawn, trees, shrubbery or evergreens, spray the edges of flower beds, trunks of trees, the bases of shrubbery and evergreens, patches of lawn, etc. lightly every day or every other day with the repellent. Stray animals are frequently attracted to areas where urine or feces have been deposited. First, remove any droppings, then spray the spot with this masking odour. Re-apply daily until undesirable habits of your pet or stray animals are changed. Discontinue use once the undesirable habit has broken. Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. Apply only in areas adjacent to buildings. Do not apply in wildlife habitat areas (e.g., parklands, forested areas). DO NOT apply in areas where plants are grown for food or feed (e.g., vegetables, fruit, and herbs).

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Pressurized contents. Do not store at temperatures above 50°C or place container in hot water or near radiator or stove, or where excessive temperatures may be encountered. Do not puncture or incinerate. Do not apply to food crops. DO NOT APPLY TO FOOD/FEED CROPS OR ANIMALS. Avoid contamination of food and foodstuffs. Avoid contact with skin, eyes and clothing. Avoid inhalation of spray. Wear rubber waterproof gloves when applying this product by hand. Wash hands with soap and water after use and before eating and smoking. Do not apply this product in a way that it will contact any person or pet, either directly or through drift. Do not allow persons or pets to enter treated area until spray has dried. Do not treat pets with this product. Do not apply in wildlife habitat areas (e.g., Parklands, forested lands).

ENVIRONMENTAL HAZARDS: Do not apply directly to aquatic habitats (such as lakes, rivers, sloughs, ponds, coulees, prairie potholes, creeks, marshes, streams, reservoirs or wetlands) or estuarine/marine habitats. DO NOT contaminate water by cleaning equipment or disposal of wastes.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
