K eep room closed for 15 minutes. Ventilate sealed areas after treatment. About 12 s econds of spraying clears an average size room (28 cubic metres).

CRAWLING INSECTS: Cockroaches, silverfish, fleas. Spray hiding places such as baseboards, cracks, openings ar ound plumbing, behind cabine ts, etc. Crawling insects must be hit with spray to be killed.

ANTS: Spray trails, hills, around wind ows and sills and openings around pipes and baseboards where ants crawl, hitting as many as possible.

FLEAS: Spray floors, floor coverings and sleeping quarters of pets. Repeat spraying as often as necessary.

SPIDERS AND CENTIPEDES: Spray webs and crawling places, hitting all visible pests.

CARPET BEETLES: Hit these bugs dire ctly on section of floor, baseboards and underside of carpets. Repeat at frequent intervals.

BED BUGS: Take beds apart. Spray frames, joints, mattresses, particularly tufts and seams, floor boards, mouldings, baseboards. Repeat at frequent intervals.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Cover fish bowls and remove animals for one hour when spraying rooms. Avoid inhalation. Cover food and food utensils. Do not spray directly on skin or animals. KEEP FROM FREEZING. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves, or other sources of heat. Do not punct ure or incinerate container or store at temperatures over 50 deg C.
