Laundry: Dilute 40 to 50 mL of this product in 1 litre of water and pour in your wash water before adding laundry. Can be used on whites and fast colours. Safe for nylon, orlon and terylene. Do not use on wool, silk or leather. 4. Superchlorinate weekly with 1 L of this product per 10,000 L of pool water when average daily

5. For visible algae superchlorinate using 2 L of this product per 10,000 L of pool water. Heavy algae

infestation may require dosages up to 3 L per 10,000 L of pool water. Vacuum pool when dead algae settles.

6. For wading pools, chlorinate daily to maintain a chlorine residual of 3 - 5 ppm by adding 45 mL of this product per 1,000 L of pool water, or as needed.
