FIRST AID:

If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

DIRECTIONS FOR USE :

This product is used in the control of objectionable slime-forming and otherwise detrimental organisms in pulp and paper mill systems. This product should be added directly to the mill system at a rate of 0.22 to 0.82 kg per tonne of pulp and paper produced, depending on the severity of the situation.
