For use in homes, restaurants, food processing plants, warehouses and industrial installations for application by Pest Control Operators and other trained personnel.

**DIRECTIONS FOR USE: GENERAL:** This insecticide is designed for use undiluted in ultra-low volume aerosol generators (foggers) that produce particles in an acceptable ultra-low volume droplet size range. It can be diluted with a deodorized base oil and applied in conventional fogging equipment that produce aerosol particles in a larger than ultra-low volume droplet size range. It can also be diluted with the oil specified and applied as a contact spray to kill crawling insects specified on this label. Do not apply while food processing is underway.

**SPACE SPRAY - Undiluted in ultra-low volume aerosol generators, to kill flies, mosquitoes, fleas, small flying moths and biting midges.** Cover or remove exposed food and food handling surfaces. Close room and shut off all air-conditioning or ventilating equipment. Apply at the rate of 10 mL of undiluted concentrate per 100 m<sup>3</sup> of space. Direct output from aerosol generator upward towards upper corners of room and ceiling. Leave room closed for one half hour. Ventilate room thoroughly before re-entry.

**SPACE SPRAY - Undiluted in ultra-low volume aerosol generators, to kill cockroaches, spiders and other crawling insects.** Cover or remove exposed food and food handling surfaces. Close room and shut off all air-conditioning or ventilating equipment. Apply at the rate of 20 mL of undiluted concentrate per 100 m<sup>3</sup> of space. Leave room closed for one half hour. Ventilate room thoroughly before re-entry.

**SPACE SPRAY - Diluted for Conventional fogging equipment - to kill flies, mosquitoes, small flying moths and biting midges.** Cover or remove exposed food and food handling surfaces. Close room and shut off all air-conditioning or ventilating equipment. Dilute concentrate with oil at the rate of 1 part concentrate to 29 parts of oil and mix well. Apply at the rate of 200 mL dilute spray per 100 m<sup>3</sup> of space. Direct fog upward towards upper corners of room and ceiling area. Leave room closed for one half hour. Ventilate room thoroughly before re-entry.

**CONTACT SPRAY - Diluted for use with sprayers that give large wetting spray particles to kill cockroaches and accessible stages of granary insects, weevils, flour beetles, meal moth larvae and adults, cadelles, grain mites, and sawtoothed grain beetles.** Cover or remove exposed food and close room as described above. Dilute concentrate with oil at the rate of 1 part concentrate to 29 parts of oil and mix well. Spray outside walls of grain bins, flooring, about base of milling machinery, walls and baseboards, areas behind cabinets, around pipes, and other insect harbourages using 16 L of spray per 100 m<sup>2</sup> of surface. Force spray into all cracks and crevices. Repeat applications as necessary.

**DO NOT USE IN FLOUR MILLS. DO NOT USE IN BULK FOOD STORAGE AREAS.**

**LIMITATION:** In meat packing and food processing plants, only spray when plant is **not** in operation. No exposed food products, ingredients or packaging materials to be left in the room. Cover all food processing surfaces and food handling equipment. Any treated surface that may contact meat food products or other food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing. In homes or dwellings, remove or cover all exposed foods and cooking utensils before spraying.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Harmful if inhaled, swallowed or absorbed through the skin. Avoid inhalation of, or contact with the spray. Keep children away from the spray. Wash thoroughly after use. Avoid contamination of feeds, foodstuffs, milking utensils and water supplies. Wear a mask or respirator when applying spray mist. Wear protective clothing. Do not spray closer than 1 metre to fabric. Do not spray on plastic or varnished surfaces. Do not treat dairy barns. Do not apply to pastures occupied by dairy animals. Do not apply to food crops. Do not spray into or near open flame. Highly toxic to fish and bees. To protect fish and wildlife and bodies of water which may be used for irrigation or domestic purposes, do not contaminate streams, lakes or ponds. Wash contaminated clothing before reuse.

**FIRST AID: If on skin or clothing,** take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. **If in eyes,** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. **If inhaled,** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment. **If swallowed,** call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically. This product contains a petroleum distillate.

**DISPOSAL:** Triple- or pressure-rinse the empty container. Add the rinsings to the spray mixture in the tank. Follow provincial instructions for any additional required cleaning of the container prior to its disposal. Make the empty container unsuitable for use. Dispose of the container in accordance with provincial requirements. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

**NOTICE TO USER:** This pest control product is to be used only in accordance with the directions on the label. It is an offence under the *Pest Control Products Act* to use this product in a way that is inconsistent with the directions on the label.
