Use a good dusting machine to give maximum coverage. Apply dust to the beds immediately after flies appear. Houses should be as dry as possible, the door closed, and air temperature up to 15°C. Repeat treatment once a week, or as required. DO NOT PICK WITHIN 48 HOURS AFTER TREATMENT.
