DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the *Pest Control Products Act*.

#### FIRST AID:

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

#### TOXICOLOGICAL INFORMATION:

This product may cause severe irritation to the eyes. Overexposure to 2,4-D may cause coughing, burning, dizziness or temporary loss of muscle coordination. Other possible effects of overexposure include fatigue, muscle weakness or nausea. Treat symptomatically.

##### PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if swallowed. Harmful if absorbed through skin. Avoid contact with skin, eyes or clothing. Remove contaminated clothing and wash before reuse. Wash thoroughly after handling. Harmful if inhaled. Avoid breathing dust.

##### ENVIRONMENTAL HAZARDS

Do not discharge into lakes, streams, ponds or public waters.
