Grotanol* SR-1 is harmful if swallowed. Avoid skin contact and splashing in eyes. All mixers and other handlers must wear: Long-sleeved shirt and long pants, shoes plus socks, chemical-resistant gloves, goggles or faceshield.

Formaldehyde can be released during use of this product. Ensure that formaldehyde air concentrations in the workplace do not exceed the exposure levels established by the occupational health and safety authorities in your jurisdiction (e.g. engineering controls, monitoring). If values exceed this level, wear NIOSH-approved respiratory protection.

DIRECTIONS FOR USE:

Machine cleaner must be added by closed system transfer.

1. 1-3% Grotanol* SR-1, depending upon coolant contamination, should be added during the last shift allowing at least a 6 hour cleaning period before draining the coolant.
2. Disinfect machine surfaces not reached by the circulating coolant/cleaner with 0.54% solution of Grotanol* SR-1.
3. Flush with clean water.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

FIRST AID:

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Contains caustic soda. If swallowed, drink large quantity of bicarbonate of soda solution, lemon juice, orange juice or if not available water. Call physician or Poison Control Centre immediately.

DISPOSAL:

1. Triple- or pressure-rinse the empty container. Add the rinsings to the treatment site.
2. Follow provincial instructions for any required additional cleaning of the container prior to its disposal.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.

5. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the manufacturer.
