### PREVENT ACCESS BY UNAUTHORIZED PERSONNEL

Do not get in eyes or on skin or clothing. Wear goggles or face shield when handling. Wear a long-sleeved shirt, long pants and chemical-resistant gloves when handling product. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Do not inhale vapours. Wash well after handling and before eating, drinking and smoking. Wash contaminated clothing with soap and hot water before reuse. Do not wear contaminated shoes. Do not contaminate irrigation water, lakes, streams or ponds by cleaning of equipment or disposal of wastes.

## FIRST AID

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Registration Number with you when seeking medical attention.
