**DIRECTIONS FOR USE:** To be used only in the manufacture of a plant growth regulator which is registered under the Pest Control Products Act. Read the technical bulletin for formulation details.

**PRECAUTIONS:**

**PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. DANGER** Corrosive. Causes eye damage and skin irritation. Do not get in eyes, on skin, or on clothing. Wear goggles or face shield and rubber gloves when handling. May be fatal if adsorbed through skin. Harmful if swallowed. Do not inhale vapours as this product will irritate skin and mucous membranes. Avoid spray drift to nearby crops as this product may cause temporary modifications in plant growth. DO NOT discharge effluent containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters. Do not use in equipment or in containers that will be used for other agricultural chemicals.

**FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**In case of eye contact**, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If on skin or clothing**, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

**IF swallowed**, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If inhaled**, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.
