#### **PRECAUTIONS:**

The following use levels (% by weight) are for Polyphase CST-1 addition to exterior and interior paints for dry film preservation. In order to determine the most cost effective use level for Polyphase CST-1 in a given use, field trials, performed within the label rate are suggested. **EXTERIOR PAINT (Solvent):** 0.5 - 1.5%. **EXTERIOR PAINT (Latex):** 1.0 - 2.5%. **INTERIOR PAINT:** 0.2 - 0.8%.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes. DO NOT discharge effluents containing this product into sewer systems, lakes, streams, ponds, estuaries, oceans or other waters.
