**INSECTS:** Aphids, Flea Beetles, Young Grasshoppers, Leafhoppers, Leafminer, Mites, Rose Chafer, Tarnished Plant Bug, Thrips, Caterpillars, Leafroller, Loopers, Scale Insects (crawler stage only).

**DISEASES:** Black Spot of Roses, Powdery Mildew, Anthracnose.
