Water, not petroleum distillate is used as the diluent.)Within the specified use location, to enhance effectiveness of this product, apply this product directly to the listed pest where possible. Good sanitary practices should be maintained to prevent re-infestation.

APPLICATION DIRECTIONS: Follow illustrations and instructions.

1. Twist nozzle at end of sprayer to open.

- Outdoor Setting
- 2. Point sprayer away from body and press sprayer button to begin spraying. Hold down for continuous spray.
- 3. Pull ring at base of sprayer as needed to continue spraying.
- 4. Aim and spray to lightly cover. Hold sprayer 30 cm (12 inches) from the insect bearing surface being sprayed.

How to Apply:

SHAKE WELL BEFORE USING.

DO NOT APPLY AS A SPACE SPRAY OR BROADCAST APPLICATION.

Apply as a crack and crevice or spot treatment only. <u>Spot treatment</u> is localized to surface area not more than 0.2 m². Spots are not to be adjoining and the combined area of spots is not to exceed 10% of the total surface area of a room. <u>Crack and crevice</u> is an application directly into narrow openings on the surface of the structure. It does not include the treatment of exposed surfaces. Narrow openings typically occur at expansion joints, utility entry points and along baseboards and mouldings.

Instructions for inside buildings:

To Kill Ants, Cockroaches, Crickets, Firebrats, Silverfish, Sowbugs, Spiders, Red Flour Beetles, And Rice Weevils:

Thoroughly treat inside building surfaces, including cracks, crevices in walls, floors and ceilings; along and behind baseboards; around water pipes and tanks; walls behind and floors beneath appliances (e.g., refrigerators and stoves) and furniture (e.g., shelves, drawers, cabinets and storage units); around sinks, drains and pipes;, around garbage containers; around interior foundations; localized area around garbage cans; localized areas of floors and floor coverings and points of entry (e.g., around windows and doors). For silverfish, also spray the cracks and crevices in bookcases. Remove all objects before treatment of bookcases where books, clothing, toys, towels and other items are stored. Treated bookcases must be dry before replacing stored items. For ants, also spray trails and nests. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Kill Carpet Beetles: Spray edges of carpeting and under carpeting and rugs for approximately 10 seconds duration. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Treatment must only be repeated after 7 days if pest problem persists or reoccurs.

To Kill Fleas (Adult and Larvae) And Ticks (Adult and Nymphs): DO NOT apply to furniture, mattresses, linens, toys or clothing. Apply to indoor building surfaces, including cracks and crevices in walls and floors, along and behind baseboards, window and door frames, and localized areas of floor and floor coverings. Outdoors On The Exterior Surfaces Of Buildings:

To Kill Ants: For use outdoors on the exterior surfaces of buildings. Apply to the outside surfaces of foundations, under eaves troughs, around light fixtures, and places where listed pests enter (e.g., screens, doors, window frames). For (pavement) ants, spray onto ant trails, into ant nests and points of entry. Treatment must only be repeated after 14 days if pest problem persists or reoccurs.

Restrictions: DO NOT apply to any body of water. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.
