DIRECTIONS FOR USE

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Harmful if swallowed or absorbed through the skin. Avoid contact with clothing. CORROSIVE to the eye. DO NOT get in eyes. Causes skin and mucous membrane irritation. DO NOT get on skin.

When used for manufacturing, workers using this product must wear protective clothing: safety boots, coveralls, impervious gloves and safety glasses/face shield. Store away from seed, fertilizers, insecticides or fungicides.

ENVIRONMENTAL HAZARDS

TOXIC to aquatic organisms and non-target terrestrial plants.

DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

Dicamba may cause severe irritation to the eyes and irritation to the skin and mucous membranes. Symptoms of overexposure to dicamba may include dizziness, muscle weakness, loss of appetite, weight loss, vomiting, decreased heart rate, shortness of breath, excitement, tenseness, depression, incontinence, cyanosis, muscle spasms, exhaustion and loss of voice.

Treat symptomatically.

STORAGE

Keep in original container during storage. Store product in cool, dry, well-ventillated place away from seed, feed, fertilizer or other pesticides. Keep away from fire or open flame or other source of heat.

DECONTAMINATION AND DISPOSAL
