**KEEP OUT OF REACH OF CHILDREN AND/OR PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.**

## **HANDLING AND STORAGE**

## **PROTECTIVE CLOTHING AND EQUIPMENT**

An approved organic dust and vapour mask should be worn when handling AVENGE technical Herbicide. Avoid contact with the skin. Wear gloves as required.

The prescribed protective uniform for personnel in the operating area consists of a hat, coveralls, long underwear, socks, rubber boots, impervious gloves and such other protective items as may be indicated, e.g., goggles and respirator.

If handled indoors, provide mechanical exhaust ventilation.

## **DIRECTIONS FOR USE**

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*.

## **FIRST AID**

**IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.
