# **TECHNICAL PIPERONYL BUTOXIDE**



# DIRECTIONS FOR USE

Intended for use only in combination with pyrethroids and rotenone in the manufacture of insecticides, which are registered under the Pest Control Products Act.

## PRECAUTIONS:

KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. Harmful if swallowed, if absorbed through skin, or if inhaled. Avoid contact with skin and clothing. Avoid inhaling/breathing in spray. Avoid contact of undiluted material with skin. Remove spillage from skin and clothing with warm water and soap. Avoid contamination of food and feedstuffs.

### FIRST AID:

In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. If in contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for treatment advice. Have person sign a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

## **DISPOSAL & DECONTAMINATION:**

Drums may be reused after thorough cleaning and reconditioning. If not, make container unusable for further use and dispose of in accordance with provincial requirements. Canadian formulators of this technical should dispose of unwanted active and containers in accordance with municipal or provincial regulations. For additional details and clean up of spills contact the Provincial Regulatory Agency or the Manufacturer.

### STORAGE:

Keep in original container during storage. Store product in cool, dry, well-ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat.
