DIRECTIONS FOR USE:

This product is to be used only in the manufacture of a pesticide registered under the *PEST CONTROL PRODUCTS ACT*.

PRECAUTIONS:

1. PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.
2. Avoid contact with skin, eyes, and clothing. Contact with skin or eyes may cause irritation. Inhalation of high concentrations of dust may irritate throat and respiratory tract.
3. Wash hands and exposed skin thoroughly with soap and water after use, and before eating, or smoking.
4. This product is moderately toxic to fish. Keep out of lakes, ponds or streams. Do not contaminate water by cleaning of equipment or disposal of wastes.
5. Do not use or store near heat or open flame.

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE: Store product in original container only, away from other pesticides, fertilizer, seed, food or feed. Store in a cool, dry, well ventilated location.

DISPOSAL:
