DIRECTIONS FOR USE:

This product is to be used only in the manufacture of a pesticide which is registered under the Pest Control Products Act.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. KEEP OUT OF REACH OF UNAUTHORIZED PERSONNEL. May irritate eyes, nose, throat, and skin. May cause allergic eczema in sensitive individuals. Avoid contact with skin, eyes, and clothing. Wash thoroughly after handling and before eating, drinking, or smoking. Wash contaminated clothing with soap and hot water before reuse. Do not consume alcoholic beverages immediately before or within 24 hours after working with thiram. Avoid breathing dust. Wear a suitable dust mask, goggles and gloves. Do not contaminate food or feed. Do not contaminate any body of water.

FIRST AID:

IF ON SKIN OR CLOTHING, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

IF IN EYES, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

IF SWALLOWED, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Consumption of alcohol in conjunction with exposure to thiram is likely to cause symptoms characteristic of the disulfiram-alcohol interaction - eg. flushing, severe pulsating headache, nausea, vomiting and palpitations.

PROCEDURES FOR HANDLING SPILLS OR CONTAINER BREAKAGE:

Cleanup personnel should wear protective equipment. Avoid creating dust. Vacuum or sweep using an inert sweeping compound, or gentle water spray to reduce dust formation. Shovel into container for disposal.

DISPOSAL:

Canadian manufacturers should dispose of unwanted active ingredients and containers in accordance with municipal or provincial regulations. For additional details and clean-up of spills, contact the manufacturer or the provincial regulatory agency.
