### **FIRST AID**

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

## **TOXICOLOGICAL INFORMATION**

If burn is present, treat as any thermal burn after decontamination. Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. If exposed, plasma and red blood cell cholinesterase tests may indicate degree of exposure (baseline data are useful). Atropine, only by injection, is the preferable antidote. Oximes, such as pralidoxime chloride, may be therapeutic if used early; however, use only in conjunction with atropine. In case of severe acute poisoning, use antidote immediately after establishing an open airway and respiration.

Do not ship or store with food, feeds, drugs or clothing.

# **ENVIRONMENTAL HAZARD**

This product is toxic to fish, crustaceans and birds. Direct contamination of any body of water with this product may kill fish. Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes.

# **STORAGE**

Keep in original container during storage. Store in a cool, dry well ventilated place away from seed, feed, fertilizer or other pesticides. Do not contaminate water, food or feed by storage or disposal.
