DIRECTIONS:

- **1.** DO NOT apply when swimmers are in the immediate vicinity (a 15-minute restricted-entry interval is recommended).
- 2. Initial dosage for pool water having no visible algae is 200 mL of **Omni[®] Algae Preventative 50-10** per 10,000 L of pool water.
- 3. Weekly maintenance dosage is 100 mL of Omni Algae Preventative 50-10 per 10,000 L.
- **4.** For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.
