DIRECTIONS FOR USE: Do NOT administer by mouth. Shake well before using. To control fleas and ticks on dogs and cats apply directly to animals along back, under forelegs and on other areas. Part the hair to contact skin and insure good coverage. Hold nozzle about 30 centimeters (1 ft.) away while spraying. Apply until hair is moist. Do not spray eyes, mouth or genitals of animals. Do NOT use on animals under 12 weeks of age. Consult a veterinarian before using on sick, aged, pregnant or nursing animals receiving drug or other pesticide treatment.

For effective flea & tick control, treatment of the pet should be combined with sanitation of any area used by the pet. Vacuum floors, carpets and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required. To control flea and tick infestations in animals resting places, spray the animal's quarters and other resting areas. Spray along baseboards, cracks and crevices and other areas where fleas and ticks are found. Treat these areas as a spot treatment or crack or crevice treatment at the rate of 2 seconds per 30 centimeters (1ft.) at a distance of 30 to 46 centimeters (12 to 18 inches). Can also be used inside dog houses. Do NOT reapply product for three days. Do not use on surfaces that can be damaged or stained by water. Use ONLY in well-ventilated areas, preferably outdoors. Replace animal bedding after spraying. A veterinarian should be consulted when pest infestation continues to be a problem on the pet.

PRECAUTIONS: HUMANS: KEEP OUT OF REACH OF CHILDREN. Avoid contact with pets until dry. After handling or applying, wash hands (or any other skin that came into contact with the product) with soap and water. Wear rubber gloves during the application of this product. May be harmful if inhaled, swallowed or absorbed through the skin. May cause dermal sensitization reaction. If irritation develops, stop use. Do not use in areas where food or feed is handled, processed or stored. Do not allow children or pets to contact treated surfaces until after spray deposits have dried. Avoid contamination of cooking utensils and food preparation surfaces. Do not contaminate water by improper use or disposal. PETS: Harmful if swallowed or inhaled. May irritate eyes, nose and throat. Avoid direct spray of dog's or cat's mouth, face, eyes and genitals.

FIRST AID: HUMANS: IF SWALLOWED, Call a poison control centre or doctor immediately for treatment advice.

Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give **any** liquid to the person. Do not give anything by mouth to an unconscious person. IF ON SKIN OR CLOTHING, Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. IF IN EYES, Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. IF INHALED, Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

PETS: Sensitivities may occur after using ANY pesticide for companion animals. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical or veterinary attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

STORAGE: Store container at room temperature. Do not use or store near heat or open flame. **DISPOSAL:** Do not reuse empty container. Wrap and dispose of empty container in household garbage.
