EndCoat Wood Preservative is a toned penetrating toxic wood preservative sealer and moisture repellent to protect cut ends on pressure treated lumber.

DIRECTIONS FOR USE: For exterior use only. Not for use in dwellings. For above ground use only. Apply by brush only. Do not spray or dip. Wood surface to be treated should be dry and clean. Remove all paint, varnish, wax, or any other coating that may prevent penetration. Allow to dry thoroughly before painting or re-coating. Use as supplied – do not dilute. Do not apply to wood or any surface where prolonged skin contact may occur, or on any surface which may come into contact with food, feed or drinking water. Clean equipment (brushes, trays, etc.) with mineral spirits, then with detergent and water. Harmful to plant life when wet. Allow to dry thoroughly before permitting contact. DO NOT contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

**PRECAUTIONS**. KEEP OUT OF REACH OF CHILDREN. Flammable. Do not use or store near open flame or spark or in areas subject to excessive heat. Harmful if swallowed or inhaled. Causes skin and eye irritation. Potential skin sensitizer. Avoid breathing vapours, contact with skin, eyes and clothing.
