DIRECTIONS FOR USE: For control of cockroaches, ants and silverfish in the home and ants outdoors. Apply as a crack and crevice treatment in places where these insects are seen, such as cupboards, closets and basements. Special attention should be given to cracks and crevices, wall voids, voids behind the kitchen counter kick plate and beneath sinks, behind large kitchen and laundry appliances and garbage can s. Any powder visible in living areas after application must be brushed into cracks and crevice, or removed.

Do not apply to damp surfaces. Powder works effectively only when dry. Do not place in areas accessible to children and pets. Leave powder undisturbed for 2 weeks. Reapply as necessary. Powder adheres to insects upon contact. Insects will contaminate other insects when they return to resting sites. Lethal effect to insects occurs several days after exposure. Close container tightly after using and store in cool dry place.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND DOMESTIC ANIMALS. Harmful if swallowed. Avoid contamination of food, feedstuffs, and kitchen utensils. Avoid breathing dust. Do not apply to flower pots, grass or to the roots of trees, etc. Wash hands thoroughly after use.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. **If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. **If in eyes:** Hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. Take container, label or product name and P.C.P. Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: Do not reuse empty container; dispose of in garbage.
