**DIRECTIONS FOR USE:**

To be used only in the manufacture of a herbicide, which is registered under the *Pest Control Products Act*. Formulations made from this manufacturer's concentrate containing dichlobenil may have different properties and uses. **USE PRECAUTIONS:**

Do not contaminate water by cleaning of equipment or disposal of wastes. Do not contaminate water used for irrigation or domestic purposes. Do not store near food or feed products. Do not store near fertilizers, seeds, insecticides or fungicides. Thoroughly clean equipment used with this product with a suitable chemical cleaner before use for other purposes.

**PRECAUTIONS:**

1. KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.
2. Wear goggles or a face shield, long pants and long-sleeved shirt, chemical-resistant gloves and chemical resistant footwear plus socks when involved in mixing/loading, clean-up and repair activities.

**FIRST AID:**

**In case of contact with skin or clothing:** Take off contaminated clothing. Do not wear contaminated shoes. Rinse skin IMMEDIATELY with plenty of water for 15 – 20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
