CONTROLS ALGAE IN SWIMMING POOL WATERS

Directions for Use:

1. Initial dosage for pool water having no visible algae is 130 mL of POD-SP30 LIQUID ALGAECIDE per 10,000 liters of pool water.

2. Weekly maintenance dosage is 45 mL of POD-SP30 LIQUID ALGAECIDE per 10,000 liters of pool water.

3. For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.

4. For visible algae growth, when superchlorination product is not employed, add 200 mL of POD-SP30 LIQUID ALGAECIDE per 10,000 liters of pool water.

FIRST AID

If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.
