DIRECTIONS FOR USE

To be used in the manufacture of a product which is registered under the *Pest Control Products Act*. DantobromTM is a TECHNICAL for use as a disinfectant, algaecide, fungicide, bactericide and /or slimicide, bactericide and/or slimicide for swimming pools, recirculating water systems. Reformulated or repackaged products must be properly registered by the repackager or reformulator.

This product should not be mixed with other chemicals, organic matter or moisture. Such use may cause a violent reaction leading to fire or explosion.

PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. HIGHLY CORROSIVE. Fatal or poisonous if swallowed. DO NOT take internally. May be fatal if inhaled. Avoid breathing dust. Use with adequate ventilation. Corrosive to eyes and skin. DO NOT get in eyes, on skin or clothing. Potential skin sensitizer. Wear rubber gloves and goggles or face shield when handling. Wash thoroughly after handling. Immediately remove contaminated clothing and wash before reuse.

FIRST AID:

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION:

Probable mucosal damage may contraindicate the use of gastric lavage. Treat symptomatically.

NOTICE TO USER:

PHYSICAL AND CHEMICAL HAZARDS:

If possible, isolate container in open air or well ventilated area, if necessary flood with large volumes of water.
