### **PRECAUTIONS**

### KEEP OUT OF REACH OF CHILDREN AND UNAUTHORIZED PERSONNEL.

Fatal if swallowed. May be fatal if inhaled or absorbed through the skin. Do not get in eyes, on skin, or on clothing. Wear natural rubber gloves, protective clothing, and goggles. In case of contact, wash IMMEDIATELY with soap and warm water. Wash hands, arms, and face thoroughly with soap and water before eating or using tobacco. Wash all contaminated clothing with soap and hot water before reuse. DO NOT CONTAMINATE FOOD OR FEED.

# FIRST AID

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person. If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice. If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

### TOXICOLOGICAL INFORMATION

**SYMPTOMS OF POISONING:** A sense of "tightness" in the chest. Sweating. Contracted pupils. Stomach pains. Vomiting and diarrhea.

**ANTIDOTE** - Administer atropine sulfate in large therapeutic doses. Repeat as necessary to the point of tolerance.

Propoxur inhibits cholinesterase resulting in stimulation of the central nervous system, the parasympathetic nervous system, and the somatic motor nerves. Do not give morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning, even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.

## ENVIRONMENTAL HAZARDS

This product is toxic to fish and wildlife. Keep out of lakes, streams, and ponds. Do not contaminate water by cleaning of equipment, or disposal of wastes.

**DECONTAMINATION:** In case of spillage, sweep up and dispose of in a landfill approved for pesticides. Wash area with strong lye solution. Do not reuse container.

DISPOSAL: Canadian formulators of this technical should dispose of unwanted active and containers in accordance with municipal or provincial regulations. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency.
