#### DIRECTIONS FOR USE:

To be used in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT. BARDAC 205 M is a TECHNICAL for formulating purposes only. Formulators are responsible for their own registrations. This product should not be used or compounded with any reducing or oxidizing agents (such as calcium hypochlorite, solid per chlorate or nitric acid) since such mixtures may be explosive. Do not use in conjunction with soap or any anionic wetting agent. Wear goggles or face shield, rubber gloves and respirator if mist is generated. Under certain conditions, the use of protective creams may be advisable. Wash thoroughly after handling.

#### PRECAUTIONS:

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Danger - Corrosive to eyes. Do not get in eyes, on skin, or on clothing. Harmful if swallowed. Avoid contamination of food. Wash thoroughly with soap and water after handling. This product is toxic to fish.

#### FIRST AID:
