**GUARD MIST INSECTICIDE** is engineered for highly effective use  
in the **GUARD MIST** automatic aerosol dispenser, or other  
similar type dispensers. The **GUARD MIST** dispenser  
automatically actuates the special metered valve every 7½  
minutes releasing 27.5 mg. of tiny particles which remain  
suspended in the air, killing flying insects. Within 24 hours  
the area is relatively free of small flying insects and with

continued use, control is maintained. One **GUARD MIST** dispenser is designed to protect an area of 170 m<sup>3</sup> of free-flow air space.

**DIRECTIONS:** Remove protective cap from top of can and insert can in **GUARD MIST** dispenser. Suspend the dispenser 2-3 metres from floor at a point where windflow will carry particles throughout the room. Do not install directly over food or food processing surfaces.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN.** Contents under pressure. Container may explode if heated. Do not expose to temperatures above 50°C. Do not puncture or incinerate. Cover fish bowls in treated areas while dispensing. Do not use on foods. In meat packing and food processing plants, only spray when plant is **not** in operation. No exposed meat products, ingredients or packaging materials, to be left in the room. Cover food handling equipment. Any treated surface that may contact meat food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing. In dairies, drawn milk and cream should be covered. In hospitals, do not use in nurseries or rooms where infants, ill or aged persons are confined. Avoid contact with skin and inhalation of spray mist. Wash after using. Contents toxic to fish and birds. Do not contaminate food, feed or water. Do not install directly over polished plastic or varnished surfaces. Dispose of empty container with regular garbage.

**FIRST AID:** In case of contact with eyes, hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice. In case of contact with skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice. If accidentally swallowed, call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

**TOXICOLOGICAL INFORMATION:** Treat symptomatically.

**DISPOSAL:** When container is empty, press valve to release all remaining pressure. Dispose of empty container in accordance with provincial requirement.
